Turn north; travel approximately 15-miles to the main entrance to the Red River Motorcycle Park. Pass the main gate ½-mile to gravel county road at old windmill, Turn right to 3rd gate, follow gravel road to green metal gate. Follow the pink ribbon to pit area.

TEXAS STATE TRIALS NEWS

30th Anniversary 2006 Texas State Series of Observed Trials

Please take time to read the following information as there are a number of changes to this year's format.

This year's Series is a best 5 of 9 round Series for Cadet, Rookie, Vintage, and Women's Classes and a best 8 of 9 for Novice through Master. This year, the State Series will award State Championship points to non-Texas Residents. This is a one year probationary decision and will be re-evaluated for the 2007 Series. The "hand off handlebar" ruling has been altered. The rider may now remove a hand from the handlebar from a stationary position, while footing, as long as the rider does not reposition the motorcycle with the "off hand".

These changes are for the duration of the 2006 Texas State Series. Each host club must decide, individually, to adopt these changes for non-Series events.
