Format: The Trial will be a standard traditional trials format riding in groups of 3 or 4 with 5 sections 3 loops on Saturday, and 6 sections 4 loops on Sunday.

Motorcycle Helmets Required - DOT, Snell, or NATC approved ONLY!

Directions: Located in Bulcher, TX 15-miles north of Muenster, TX on FM Road 373. From Interstate 35 in Gainesville, TX travel west on Hwy 82 to Muenster to only stop light. This is FM 373. Turn North, travel approximately 15-miles to the main entrance to the Red River Motorcycle Park.

NOTE: Everyone must stop at main gate. At the main gate, be sure to state that you are here for the NTTA Trial, or you'll be charged a higher fee. See <http://www.redrivermotorcycletrails.com> for the new park rules and other information.
